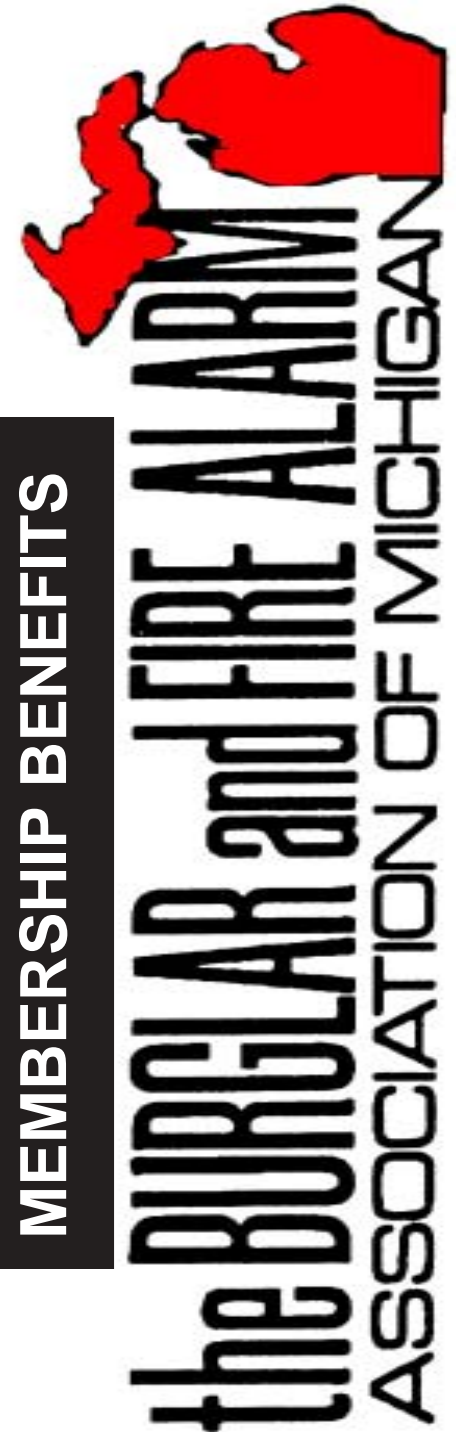
We have upgraded the alarm industry, encouraging constant improvement in the quality and professionalism of the products and services offered to the public by the industry.
